

General Terms of Use for the Websites regarding the service "Teampplace"

Before visiting and using any of the Websites of the Cortado Mobile Solutions GmbH (hereinafter referred to as "CMS"), represented by the Managing Directors, Alt-Moabit 91 a, 10559 Berlin, Germany, please read the following General Terms of Use (hereinafter referred to as "GTU") regarding the service "Teampplace". The GTU apply to any and all websites registered to Teampplace, regardless of the name "Teampplace" being part of the web-address. You automatically declare your consent and compliance with the GTU upon access to and use of such websites. If you, however, disagree with the GTU, please refrain from accessing and using any of CMS's websites and their contents.

1. Subject Matter of the GTU

1.1 The GTU exclusively define the terms and conditions under which CMS provides its websites to internet users and the terms under which said users may access and use such websites regarding the service "Teampplace".

1.2 The GTU apply to every connection established to any of the Teampplace-websites.

1.3 CMS reserves the right to modify or add contents to its websites and the elements presented therein at any time without previous announcement.

2. Access to the Service

2.1 CMS's websites may be accessed at any time all around the clock, except in cases of force majeure or events beyond the control of Teampplace and in cases of any arising disruptions or maintenance procedures required for orderly function of the websites.

2.2 All rights granted to internet users by Teampplace-websites are not transferable.

3. Intellectual Properties

3.1 Any and all contents of Teampplace-websites, including but not limited to data, information, logos, brands, logotypes, texts, and illustrations and their arrangement on Teampplace-websites are subject to all available national and international copyright law and other laws regarding intellectual property. In particular all rights regarding the contents and design of Teampplace-websites are strictly reserved by CMS. Information and images offered on the website are copyrighted.

3.2 Any and all complete or partial copy, reproduction, modification, replay, display, transfer (in electronic or any other form), any type of access to third parties, including any and all adaptation, distribution, or any other use of any and all content of Teampplace-websites (including all texts, images, graphics, audio and video files) for public or commercial purposes, regardless of the methods used, is prohibited without previous express written consent from CMS.
